- By 22 May 2026, **Kuwait** deposited its instrument of accession. Date of entry into force on 21 June 2026.
- By 23 April 2026, **Vanuatu** deposited its instrument of accession. Date of entry into force on 23 May 2026.
- By 14 April 2026, **Cameroon** deposited its instrument of ratification. Date of entry into force on 14 May 2026.
- By 7 April 2026, **Libya** has deposited its instrument of accession. Date of entry into force on 7 May 2026.
- By 26 January 2026, **Brunei Darussalam** has deposited its instrument of accession. Date of entry into force on 25 February 2026.
- By 25 December 2025, **Ecuador** has deposited its instrument of ratification. Date of entry into force on 24 January 2026.
- By 10 December 2025, **Estonia** has deposited its instrument of accession. Date of entry into force on 9 January 2026.

- By 25 April 2022 (date of deposit 18 May), **The Netherlands** have accepted the Convention on the International Organization for Marine Aids to Navigation for the European part of the kingdom and by 12 July (date of deposit 29 July) for the Caribbean part of the kingdom (the islands Bonaire, Sint Eustatius and Saba).
- By 17 January 2022, **Panama** has ratified the Convention. Date of deposit 26 April 2022.
- By 28 December 2021, **India** has ratified. Date of deposit 10 January 2022.
- By 7 December 2021, **Malaysia** has ratified. Date of deposit 16 December 2021.
- By 13 July 2021, **Japan** has accepted the Convention. Date of deposit 13 July 2021.
- By 28 May 2021, **Norway** has ratified the Convention on the International Organization for Marine Aids to Navigation. Date of deposit 13 July 2021.
- On 2 March 2021, **Singapore** ratified the Convention on the International Organization for Marine Aids to Navigation. It is the first country to do so shortly after it signed the Convention on 1 March 2021. Date of deposit 2 March 2021.
