## IALA Patent Policy Notes

### 1 SUMMARY

This paper describes measures taken by IALA to avoid Patent difficulties.

#### 1.1 Purpose of the document

This paper is to inform the PAP of measures taken by IALA to avoid Patent difficulties.

The paper should be read in conjunction with the draft Guideline on Patent Policy and Procedures 20150423 which has been submitted separately to PAP29.

### 2 INTRODUCTION

To encourage the early disclosure and identification of Patents that may relate to IALA Standards, Recommendations, Guidelines under development and in doing so achieve greater efficiency in documents development and avoid potential patent rights problems, and to protect IALA and its members against patent development based upon IALA technical work, IALA has instituted the following measures.

### 3 GUIDELINE ON PATENT POLICY AND PROCEDURES

The draft guideline has a twofold purpose:

1. To state the policy of IALA – to develop recommendations etc. that do not have any intellectual property right (IPR) issues; Anyone participating in IALA work will then know that this is the name of the game, and be in “bad will” if they act differently.
2. To discover any existing IPR infringements (through Committee Chairman’s statement in plenary at each meeting) and either remove them through disclosure statements or alternatively work around them using different technical solutions in the documents.

### 4 PUBLIC AREA ON IALA WEB SITE

The purpose of webpage is to stop new patents on IALA work.

The concern is that people who get access to working papers apply for patents and later demand royalties for the new standards. It is not possible to apply for patents for things that are already in the public domain, and it is therefore planned to publish various working papers on an open website.

A web page has been created on the IALA web site under Committees with the heading “What’s new in IALA Committees”. This is open to access to the public without the need for registration or password.

The page will not be subdivided. The documents will be uploaded in chronological order, with a clear indication of the date when they were published there.

#### **4.1 Document identification**

The Committees will identify any documents that should be uploaded to the “What’s new in IALA Committees” web page. Relevant documents are any document that the Committee members think might include patentable information.

Where documents already on the web page are updated, the old document will be retained on the web page.

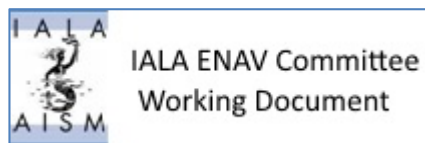
These actions will be triggered by the Committees to the Committee Secretary / IALA Secretariat.

#### **4.2 Procedure for upload**

Documents for upload will be sent to Marie-Helene Grillet for upload. Preferably, the documents should be in pdf format. However Word documents will be accepted and converted to pdf format by the IALA Secretariat.

Relevant documents will be placed on the “What’s new in IALA Committees” in PDF format, annotated as follows:

- Prominent watermark “IALA Working Document” on every page;
- With the IALA logo and the words “IALA ENAV Committee, Working Document” in the title area.
