25 May 2014

Report of the 57th Session of the IALA Council (C57)

1 OPENING

The 57th session of the **IALA Council** was held on 25 May, 2014, at La Coruna, Spain, with Mr David Gordon, South Africa, the IALA President, as Chair.

1.1 Opening remarks

The Chair opened the meeting and complimented Spain on its excellent preparation for the IALA Conference which was to commence the following day, and wished all delegates a successful week.

Vice-President, Mr Manuel Gomez, welcomed Councillors to A Coruna, thanked Mr Juan Francisco Rebollo and his team for the preparations for the Conference, and wished Councillors and delegates a fruitful Conference.

The Chair welcomed Mr Kong Hyundong from Korea, Mr Brad Groves from Australia, and Mr Mike Bullock, Northern Lighthouse Board, Scotland, as an observer

5 REPORT BY THE SECRETARY-GENERAL

The Secretary General briefed the Council on recent activity within the Organisation and highlighted the following matters:

- Since the last meeting of Council 56 in India IALA the Secretariat had been very active with a number of important events which included:
 - eNavigation Underway, Denmark
 - Extraordinary Legal Advisory Meeting, Headquarters
 - AccSeas Conference, Scotland
 - eNavigation North America
 - IMPA Conference
 - Seoul International Maritime Forum
- Completion of the 2013 Annual Report for the organisation
- Extensive preparation by the Secretariat for the Conference/Assembly and associated parallel events

The Secretary-General noted that at its 56th Session, the Council requested the Secretary-General to report to Council, what a modern and efficient Secretariat would look like, for the present form of the Association. He indicated that a project has been initiated as a result and provided an explanation and progress report as paper C57-5.1

The Secretary-General's report to the Council (paper C57-5.1) was noted.

6 FINANCIAL MATTERS

The IALA Treasurer, Captain Ian McNaught, explained that the audited Financial Statements for the year 2013 had been forwarded by e-mail before the Council session to FAC members for an out of session approval.

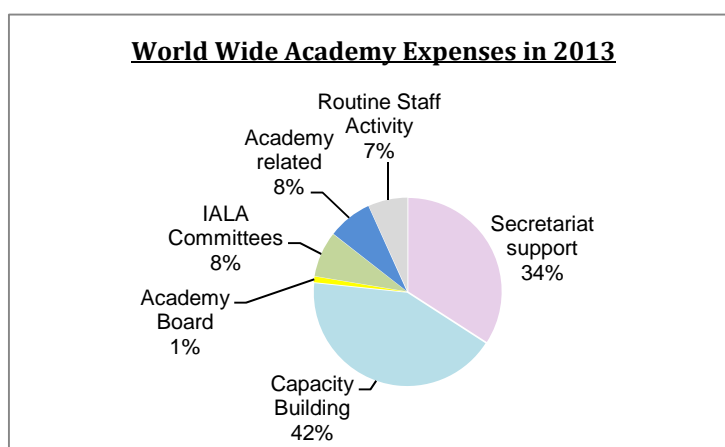
6.1 2013 Audited Financial Statements

The report of the Auditor (ANNEX C1) and the detailed financial statements (ANNEX C2) were provided for the attention of Council members. The treasurer reminded the meeting that the statements were presented in a consolidated manner, which included both IALA and WWA figures.

The consolidated balance sheet shows a positive result of €233,552.

The more significant conclusion of the 2013 Audit was the creation of a new provision for pension liabilities for IALA employees. This provision has been valued at €129,606. Another provision is registered for severance pay for a total amount of €265,932. The total of both provisions is equal to €395 538.

Furthermore, the World Wide Academy had generated a surplus of €84,670. The execution of the budget was satisfactory and the level of funds available to the WWA as at 31st December 2013 was €204,256.



The Balance Sheet for 2013 was approved.

7 IALA TECHNICAL ACTIVITIES

7.1 Policy Advisory Panel (PAP)

7.1.1 Documents to note

7.1.1.1 Report of PAP27

The Deputy Secretary-General referred to the extraordinary PAP meeting, PAP27, held in March 2014 to consider the IALA documentation policy. He indicated that it had been a great success, and thanked Denmark for permitting Mr Bjørn B Pedersen to act as meeting facilitator.

After two days of deep consideration and discussion, the PAP members had agreed on a proposal for a new IALA technical document scheme to be proposed to Council. The Secretariat still has work to do on this scheme, but intends to make an input to Council session 59.

The report of PAP27 (paper C57-7.1.1) was noted.

9.1 Documents to note

9.1.1 Report of WWA Board meeting

The Dean of the IALA WWA reported on the 6th WWA Board Meeting, held on 01 April 2014.

The Report of the 6th WWA Board meeting, paper C57-9.1, was noted.

10 IALA MEMBERSHIP

10.1 Applications for IALA Membership

Since the last Council meeting 56, the Secretariat received the following applications for IALA membership, which have been provisionally accepted by the Secretary General.

- **PT Rayo Abadi, Indonesia.** The application form and the support by the National Member were received on 28th January. The membership contribution for this year is not settled yet.

- **UK Hydrographic Office; UK.** This Organization was introduced by the IALA Deputy Secretary General. The application form was received on 19th March together with the support of the National Member. The membership contribution for this year has been settled.

- **Service National de Signalisation Maritime; Gabon.** The application was received on 15 May. The application was accepted in principle in order to enable this Organization to take part to the General Assembly during the Conference

- **Geo System Research Corporation; Republic of Korea.** Application received from the National Member Seconded Officer on 21 May. Support was given by the Councilor for Korea.
- **Shindong Digitech; Republic of Korea.** Application received from the National Member Seconded Officer on 21 May. Support was given by the Councilor for Korea.

10.2 Resignations from IALA Membership

The following organisations had resigned since Council meeting 56.

National Members

- **The Canadian Coast Guard; Canada.** The resignation letter was received in IALA on 10 April 2014. The contribution for this year is cancelled.

Industrial Members

- **Automatic Power; USA.** Due to the volume of business within Ports and Harbours Industry, this company has decided to incorporate its business with Pharos Marine, UK, and to keep only one membership of the Industrial Members Group. The company is renamed Pharos Marine-Automatic Power. IALA was notified by 7th February. The membership contribution for this year is cancelled.
- **Telenor Maritime Radio; Norway.** IALA was notified of the resignation of this company by 27th February, their business development and line products being no longer focused in the aids to navigation market area. The membership contribution for this year is cancelled.

Associate Members

- **Crescent River Pilots Association; USA.** This Organisation has notified IALA of its resignation on 18 March, due to budgetary reasons. The membership contribution for this year is cancelled. This resignation should cause to IALA a minor loss equal to €2,650 in 2014, due to unpaid fees in 2013.

The resignations were noted.

11 IALA GENERAL ASSEMBLY

11.1 Council papers for the General Assembly

The Extraordinary Legal Advisory Panel meeting had forwarded three decision papers to Council for consideration in regard to the conduct of the General Assembly. The three papers, noted below and reproduced in Annexes, were circulated to Council for out of session approval on 3 April 2014. The date for reply was 18 April 2014.

The need for out of session approval was recognised at Council 56 so that Council would have the opportunity to consider the papers, and upon approval, to enable them to be circulated in a timely manner to participants at the General Assembly (noting that Council 57 would not meet until two days prior to the commencement of the General Assembly).

In accordance with the IALA Constitution, and usual practice, the papers were approved as presented. The approved papers were circulated on 1 May 2014 for consideration by the General Assembly in its first session on 27th May 2014.

The approved papers were:

 - C: Change of Status – Frequently Asked Questions (*input paper C57-11.1.1.3*)
- Approval of changes to the IALA Constitution (*input paper C57-11.1.2*) and its Annex A- B
 - A: proposed changes to the IALA Constitution (*input paper C57-11.1.2.1*)
 - B: Input paper for General Assembly (*input paper C57-11.1.2.2*)
- General Assembly Resolution and its Annexes A-B (*input paper C57-11.1.3*)
 - A: Text of draft General Assembly Resolution (*input paper C57-11.1.3.1*)
 - B: Input paper for General Assembly (*input paper C57-11.1.3.2*)

The Council noted these out of session Approvals.

A number of Councillors, including those from China, Germany, Japan, the Netherlands, and Norway, raised points concerning the proposed changes to the Constitution, especially the proposed changes to Article 13.

Japan asked that the following text be included in the minutes.

“Japan proposed some modifications such as approval of standards by General Assembly, two thirds majority of all members for the termination of IALA to the draft amendment of the Constitution and other related documents taking into consideration of risks and concerns associated with this status change in the last e-mail vote. Regrettably these were not accepted though, we consider that these risks and concerns still remain and are not solved. Therefore Japan would like to raise these risks and concerns including our proposal again at the coming General Assembly on Tuesday.

Finally, we would like to state that our comments here do not predict or reflect the position of Japanese Government and therefore our government retains its right to comment or opinion regarding the IALA status change at the future possible diplomatic negotiation. We request the Secretariat to properly record my comment to the report of this meeting.”

China raised the issue of the “one-China” policy in relation to the change of status of IALA and indicated that if IALA were to become an IGO, the Chinese government would request an MOU between IALA and China on this matter.

11.1 The Council, by recognizing that the "one-China" policy is a UN policy for all international governmental organizations, agreed to the suggested approach by China, and tasked the LAP to prepare a draft MOU and report to Council.

11.2 General Assembly Arrangements

The Arrangements for the forthcoming IALA General Assembly were noted.

12 ANY OTHER BUSINESS

12.1 Arctic Navigation

The Council noted paper C57-12.1.1 and also noted that IALA the Secretariat intends to progress discussion with the PAME Working Group of the Arctic Council, with a view to presenting draft policy proposals to Council in 2015.

The Councillor from Norway advised that the EPPR Working Group of the Arctic Council had a task force on Arctic marine pollution prevention and was discussing similar topics to those of the PAME Working Group. She suggested that the Secretariat should be aware of this in its dealings with PAME.

12.2 Resilient Navigation and Timing (RNT) Foundation

The Council noted input paper C57-12.2.1 concerning the possible signing by the Secretary-General of an MOU between IALA and the US educational and scientific charity The Resilient Navigation and Timing (RNT) Foundation.

After discussion it was decided that it would not be appropriate for IALA to enter into such an MOU. The proposal was not agreed.

13 DATE & VENUE OF NEXT COUNCIL MEETING

13.1 Session 58: 31 May 2014, La Coruña, Spain

The 58th Session of the Council will be held following the election of the new Council members during the 2014 IALA Conference.

14 CLOSING

The Chair and the Secretary-General both expressed their appreciation of the work of retiring Vice President Mr Manuel Gómez and expressed their thanks.

The Secretary-General expressed his thanks to retiring President Mr David Gordon for his leadership and fine navigation of the Council over the 2010-2014 period. Mr Gordon responded, thanking Councillors for their support and their contributions over the past four years.

This report will be circulated electronically for comment. If no comments are received by the IALA Secretariat within two weeks of its circulation, then it will be considered accepted.

III. SPECIFIC VERIFICATIONS AND INFORMATION



ANNEX D ACTION ITEMS

11.1 The Council, by recognizing that the "one-China" policy is a UN policy for all international governmental organizations, agreed to consider the request of China, and tasked the LAP to prepare a draft MOU and report to Council.

ANNEX E POST MEETING COMMENTS

Post the conclusion of Council 57, the majority of Councillors approved the draft report as distributed.

The following comments from Japan were received and included as a post Council meeting comment with an IALA Secretariat response.

Comment 1:

The third paragraph of Chapter 11.1, page 9, mentioned “the paper were approved as presented.” I would like to recall your attention to the discussion of this agenda that Chinese Councilor requested the outcome of e-mail vote on this matter and the Secretariat answered the number of approval, reservation and objection. IALA now decided to strive its status change to IGO and I believe that one of the important aspect of IGO is transparency. Therefore, it would be better to record the outcome in this report and this method is also better to be applied to the future Council meeting report:

Secretariat response:

Paragraph 11.1 of the report was amended to reflect the number of Councillors having rejected the papers or expressed reservations, and the number of Councillors having either approved them or not responded.

Comment 2:

The middle paragraph of the same page writes “A number of Councilors, including those from China, Germany, Japan, the Netherlands, and Norway, raised points concerning the proposed changes ...” From this sentence, it is not clear what the points are, especially for those who did not attend the meeting and the national members other than the Councilor. In order to draw attention of other National Members on this important issue, it would be better to clarify what the points are, not detailed but essential part of the points. I believe that this crucial issue does need the involvement of all National Members and clarifying the discussion points could contribute to the future discussion on this issue by all National Members.

Secretariat response:

IALA Council reports are documented in a similar manner to that of the IMO Council, with a summary of decisions recorded, and generally without verbatim Council reports. The point raised by Japan is a matter of significance for IALA and it is considered that the actual report of General Assembly 1, documents in sufficient detail the issues raised by respective National Members, both for and against the proposed changes to the IALA Constitution.
