



Draft letter to Industrial and Associate members.

IALA will soon become an Intergovernmental Organization.

Dear Member, XXXXX

As you are probably aware, the change of status of IALA to an Intergovernmental Organization (IGO) is now entering the final phase. The *Convention on the International Organization for Marine Aids to Navigation* will enter into force on the ninetieth day after the date of deposit of the thirtieth instrument of ratification, acceptance, approval or accession.

At the date of this letter [five] States have completed this formal process. We do not know when the required number will be reached, but we are preparing for transition to the new Organization so that IALA's vital work continues without interruption.

Transition arrangements

A General Assembly must be held within six months after the IGO is created. During that period the current IALA structures, rules, contributions and arrangements will apply with minor modifications. The General Assembly will approve its own Regulations, which we expect to be modelled significantly on those currently in place.

However, in accordance with the annex to the Convention, the relevant Transition arrangements for your organization to remain a part of IALA from its commencement are as follows:

[7] All Associate and Industrial Members of the International Association of Marine Aids to Navigation and Lighthouse Authorities up to date with their fees shall, subject to their formal request, become Affiliate Members of the Organization.

This means that current Industrial and Associate members can still participate in IALA with the new status of 'Affiliate' member', so the transition will basically just mean a change of membership name, and we look forward to your continued contribution.
