## Report of the 42<sup>nd</sup> Session of the IALA Vessel Traffic Services (VTS) Committee

### Executive Summary

The 42<sup>nd</sup> Session of the VTS Committee was held in Kuala Lumpur, Malaysia prior to the 13<sup>th</sup> VTS Symposium.

77 Members from 24 countries, 2 sister organisations and 2 observers participated in VTS42; 11 participants for the first time;

This was the fifth meeting for the 2014-18 Work Programme and the VTS Committee considered 52 input papers and produced 9 output papers of three Working Groups.

Key outputs included:

- Significant progress on Task 1.4.2 Review/Update/Provide input to IMO on Resolution A.857(20) Guidelines for VTS was achieved with completion of a paper on the compelling need for a revision of IMO Resolution A.857(20) Guidelines for Vessel Traffic Services (Information Paper VTS42-12.1.3). The paper provides the basis for the Committee to commence drafting a submission to the IMO requesting a review of the Resolution as an unplanned output.  
Note: While IALA may draft the document the submission can only be made by a Contracting Government / Member State of IMO.
- Completion of Task 1.1.3 on a new Guideline on Marine Casualty Incident Reporting and Recording including near-miss situations as it relates to VTS
- Completion of Task 1.4.3 on developing and conducting a global VTS Questionnaire The report of the Questionnaire will be released at the VTS2016 Symposium in Malaysia, 8-12 August 2016 and posted on the IALA website.

The Questionnaire will be kept online to enable:

- Authorities who have not already responded to do so, and
- Authorities who have responded to update their responses as necessary (for example, a new VTS has been authorised).

- Updates of definitions and abbreviations of the IALA Dictionary.

The following liaison notes were prepared:

- to Council to approve the Guideline on Marine Casualty Incident Reporting and Recording including near-miss situations as it relates to VTS;
- to ENAV on the e-navigation Road Map;
- to ARM on Marine Spatial Planning;
- to the Joint VTS-ENAV WG on the ACCSEAS Legacy report.

Feedback was given on the report of the IALA VTS Questionnaire report.

Members expressed significant concern over the policy to remove definitions from IALA documents as this will impact the readability, accessibility and understanding of the documents.

## Report of the 42<sup>nd</sup> Session of the IALA Vessel Traffic Services (VTS) Committee

### 1. INTRODUCTION

#### 1.1 Opening Ceremony

Michael Card, Deputy Secretary General of IALA, welcomed all participants to the 42<sup>nd</sup> meeting of the Vessel Traffic Systems Committee in Kuala Lumpur, Malaysia. He welcomed in particular the Honourable Datuk Seri Haji Saripuddin Bin Haji Kasim, Secretary General of the Ministry of Transport Malaysia, the Honourable Dato' Haji Baharin Dato' Abdul Hamid, Director General of the Marine Department Malaysia and Mr. Roslee Mat Yusaf, Director Safety of Navigation of the Marine Department Malaysia.

Michael Card thanked the Marine Department Malaysia for all the arrangements made for this meeting and highlighted:

- the key tasks the Committee would be focussing on during the week
- the workshop on VTS Communications in Indonesia early next year
- the developments in digital communications like VDES
- the joint meeting between the VTS and ENAV Committees after VTS42.

The Honourable Datuk Seri Haji Saripuddin Bin Haji Kasim, Secretary General of the Ministry of Transport Malaysia welcomed the IALA VTS Committee with participants from all over the world as a platform of experts. He highlighted the role of the Ministry of Transport in improving the VTS in Malaysia in operation, technical support and training of personnel. He hoped to welcome all participants in the next week VTS Symposium 2016 and opened the Committee meeting officially.

To memorise this meeting some gifts were handed to and from the IALA and the Ministry of Transport.

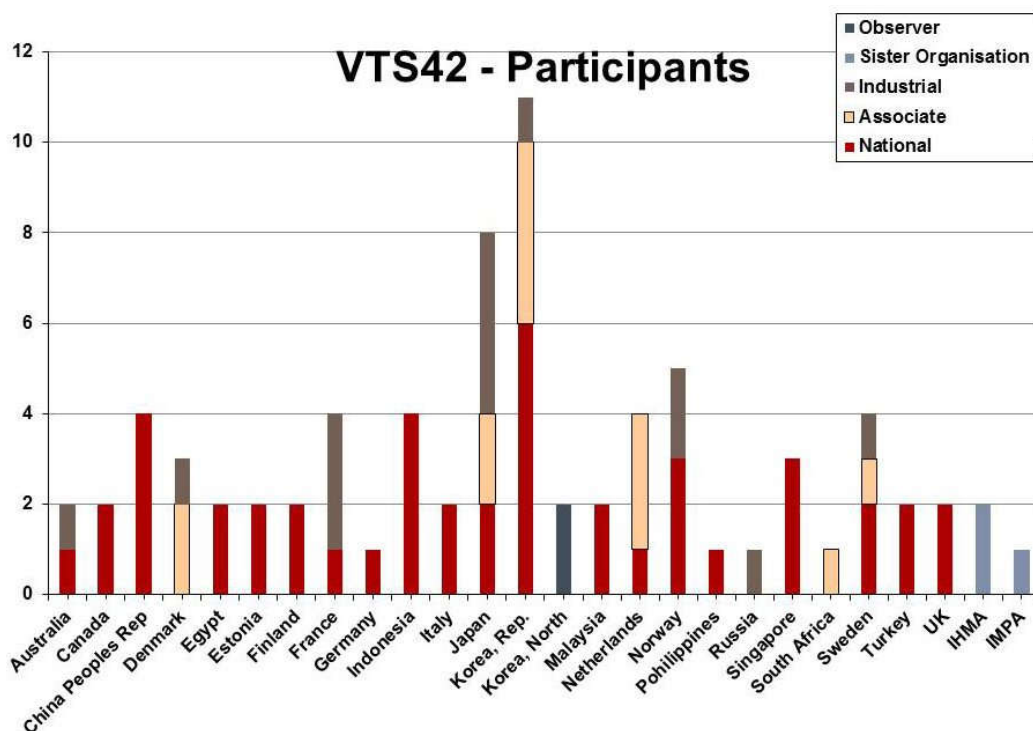




## 1.2 Plenary Session

The 42<sup>nd</sup> meeting of the VTS Committee was held from 1 to 5 August 2016 at the Impiana KLCC Hotel, Kuala Lumpur, Malaysia with Tuncay Çehreli as Chair and Neil Trainor as Vice Chair. The Secretary for the meeting was Wim van der Heijden.

77 Members from 24 countries and 2 Sister organisations participated in VTS42; 11 for the first time. There were 2 observers.



The Chairman welcomed all participants to VTS42 in particular the members returning after some absence and the members participating for the first time. He also thanked the Marine Department for the excellent organisation of the Committee meeting back to back with the VTS2016 Symposium.



### 1.3 Administrative announcements

Hairizam Al Bukhari informed the Committee about the arrangements made for the meeting with respect to the meeting rooms, lunches, coffee breaks and Committee dinner.

### 1.4 Approval of the agenda

The agenda was reviewed and adopted (VTS42-1.2) with the addition of an additional report from IMO on Trends, Developments and Challenges facing the IMO in the 2018 – 2023 period (agenda item 4.3).

### 1.5 Introductions and apologies

The Chair welcomed the new members of the Committee. Apologies received are listed in Annex B.

### 1.6 Programme for the week

The Chairman explained the programme for the week (VTS42-1.4) which was adopted.

## 2. REVIEW OF ACTION ITEMS FROM VTS41

Input paper VTS42-2.1 refers.

### 2.1 Action Items – IALA Secretariat

It was noted that all IALA Secretariat actions from VTS41 had been completed.

### 2.2 Action Items – VTS Committee Members

1. Action item 31 (NAS questionnaire). Malin Dreijer reported verbally on the status
2. Action item 32 (marine casualty / incident reporting). Inputs from Australia and France were received.
3. Action item 33 (effective communication). Inputs received included VTS42-8.5.2.
4. Action item 34 (review working paper VTS41-12.2.2). No inputs received.
5. Action item 35 and 36 no actions were required.

## 3. REVIEW OF INPUT PAPERS

Before the review of the input documents, the Committee Secretary gave a brief introduction of the document handling. He highlighted how to input documents to the Committee and attended to the deadline for submission of inputs to the next meeting. This will be very strict and is set to two weeks before the meeting start in order to give members time to read inputs and discuss them in their own organisation. Only one exemption will be made for documents to the Committee as output from an IALA event held in the period of two weeks before the Committee meeting (output from another Committee meeting or from an IALA workshop or seminar). This is to avoid unwanted waiting time.

He introduced the file share system to be used by Working Groups during the meeting. He highlighted the fact that all documents will be removed after one month. Output documents (real output and working documents for the next meeting) should be submitted to the Secretary directly.

Finally he introduced input and output templates in the new IALA branding and new style sheets for drafting new Recommendations and Guidelines. Recommendations and Guidelines already under development or revision can be finalised in the old style.

The list of input papers is automatically generated by the IALA web site when downloading one or more documents. Input papers are numbered in line with the agenda.

The input papers were reviewed and appointed to the working groups with the following remarks:

- IALA Dictionary (VTS42-3.1.1, VTS42-3.1.2 and VTS42-4.2.2) should be reviewed by all WG's
- S100 IVEF will be keep on hold to the next working period

- FAROS project (VTS42-3.3.1 and VTS42-3.3.2) has been noted and will be reviewed by WG3
- ACCSEAS project (VTS42-3.3.3) has been noted. WG1 and WG2 will consider the conclusions from the report
- VTS Manual (VTS42-3.3.4) was done already
- ENAV Road Map (VTS42-3.4.1 and VTS42-3.4.2) will be considered by WG2
- Marine Spatial Planning (VTS42-3.5.1 and VTS42-3.5.2) WG1 (lead) and WG2 will consider. There was a remark on the abbreviation (MSP) which can lead to confusion with Maritime Service Portfolios.

## 4. REPORTS FROM OTHER BODIES

### 4.1 IALA Council

The Committee noted the following Council report:

- 62<sup>th</sup> Session, Lisbon, Portugal, 21-24 June 2016, paper VTS42-4.1.1 refers.

The Chair informed briefly about the report and the VTS related issues.

### 4.2 IALA Policy Advisory Panel

The Committee noted the PAP31 report, paper VTS42-4.2.1 refers. The Chair briefly introduced the report and VTS related matters.

The Chair noted that there was an action item (No. 11) for the VTS Committee, stating “*The VTS Committee to develop a convincing and clear paper on the revision of IMO Resolution A.857(20) based on the compelling need for the safety of navigation, aiming to those not familiar with VTS*”.

The Chair also noted the report of the Dictionary Working Group (VTS42-4.2.2) and informed that some of the proposed definitions were rejected and should be re-considered by the Committee (see also agenda item 3 above). Members of the Committee expressed their deep concern on the IALA policy on the process for accepting and rejecting the definitions made by experts.

### 4.3 IMO documents

The following IALA reports of IMO meetings were noted: MSC96 (VTS42-4.3.1) and NCSR3 (VTS42-4.3.3). The Chair attended on VTS42-4.3.2 describing the trends, Developments and Challenges facing the IMO in the 2018 – 2023 period.

### 4.4 IALA Workshop on Shore-Based Maritime Services from Theory to Practical use

The workshop was held on 24 – 26 May 2016 in Lisbon, Portugal and there were a couple of VTS related actions defined. VTS42-4.4.1 refers. WG1 will consider the actions and report as appropriate.

## 5. REPORTS FROM RAPPORTEURS

### 5.1 Liaison with IALA WWA

Rapporteur: Kevin Gregory

Because there will be an overlap with the presentation of the WWA every meeting it was decided to remove this report from the agenda.

### 5.2 Risk management toolbox

The Risk Management Tools Steering Group will be continued as WG3 of the ARM Committee. The Chair, being member of the Steering Group, informed about the change of status. He attended the last meeting

during ARM4 by GoToMeeting. The Chair proposed to make this as a new rapporteur item for the next meetings which was agreed by the Committee.

## 6. PRESENTATIONS

### 6.1 Update IALA activities

An informative presentation was made by Michael Card. The following items were presented:

- The Council Strategy Group had a meeting before the 62th Council meeting working on the IALA Strategic Vision.
- Upcoming PAP and LAP meetings will be work on the text for the approved IALA Standards.
- Jean-Charles Leclair will be retired from the 1<sup>st</sup> of September. The new Dean of the WWA will be Omar Frits Eriksson, in function from the 1<sup>st</sup> of August 2016.
- The image of the IALA Head Quarter will be improved in line with the new IALA branding.
- For a short period IALA will have a new Seconded Officer from the Japan Coast Guard: Kinji Takeuchi.
- IALA will be represented in IMO by Mahdi Al Mosawi, SG and DSG.
- He thanked Paul Owen and Marie-Helene Grillet for their work on the new edition of the VTS Manual which will be launched during the VTS2016 Symposium.
- He attended the Industrial Members on a meeting of the IALA Industrial Members during the VTS2016 Symposium.

### 6.2 IALA VTS Questionnaire – results

Neil Trainor presented the preliminary results of the VTS Questionnaire based on the responses received from 155 individual VTSs, representing 113 Vessel Traffic Authorities and 31 Competent Authorities.

A draft report on the outcomes from the Questionnaire (was reviewed by the Committee and approved for release at the VTS2016 Symposium in Malaya 8-12 August.

Members noted that the web-based questionnaire was closed two weeks prior to VTS42 to enable the analysis to be undertaken to produce the report. Further, noting that several authorities had asked to complete the questionnaire during this time it was agreed that the Questionnaire should be re-opened to allow additional authorities to complete the questionnaire and existing respondents edit/update their responses as necessary.

### 6.3 IALA World-Wide Academy (WWA)

Paper VTS42-6.3.1 (presentation) refers.

The presentation was made by Gerardine Delanoye.

The presentation covered an overview of the VTS related activities of the WWA since VTS41 and the planned activities in the remaining part of 2016. Distance learning is progressing. A decision had been made that all information on the webpage as regards the IALA experts should be removed. Earlier the names of the experts had been removed.

She introduced the new Dean of the WWA Omar Frits Eriksson who has a lot of experience with the Academy.

The Chairman thanked all speakers for the presentations.

## 7. ESTABLISH WORKING GROUPS

The Chairman outlined the procedure to be followed by working groups, including the associated paperwork, after which three working groups were established and their tasks outlined. It was decided that the previous breakout group on the update approach of IMO Resolution A.857(20) would merge as a sub-group of WG1. A list of working group participants is at Annex C.

## 8. WORKING GROUP 1 – TD#1 - OPERATIONS (WG1)

31 participants were involved in working with the tasks of WG 1, of which 7 were at IALA for the first time. Five subgroups were created to consider the tasks, as follows:

### 8.1 Task 1.1.3 Produce a Guideline on marine casualty / incident reporting and recording, including near miss situation as it relates to VTS

The working group finalized the task and took account of comments from Australia (VTS42-8.1.4) and France (VTS42-8.1.2) and made relevant changes in the guideline, particularly with concern to the link between QMS and ISM and the explanation of a reporting culture with a just culture.

It was considered important to keep the flow chart in annex 1 in order to help the understanding of the guideline.

The Committee reviewed the guideline together with the liaison note and made some corrections and adjustments before it was agreed.

#### Action item:

*The **Committee Secretary** is requested to forward the liaison note (VTS42-12.1.1) and the draft Guideline on Marine casualty / incident reporting and recording, including near miss situations as it relates to VTS (VTS42-12.1.2) to Council for approval.*

### 8.2 Task 1.1.4 Produce a Guideline on Maritime Service Portfolios for VTS

The work continued to develop. The templates on MSP 1 (INS) and MSP 2 (NAS) were updated taking into account the result of 'IALA workshop on shore based maritime services from theory to practical use'. Useful information received from Canada on MSP 1 was also considered.

#### Action items:

*The **Committee Secretary** is requested to forward the revised templates on MSP (VTS42-12.2.1) as a working document to VTS43.*



The **Committee Members** are requested to review and provide comments on the draft template of MSP 1 (INS) (VTS42-12.2.1) before 20 February 2017 to Malin Dreijer ([malin.dreijer@kystverket.no](mailto:malin.dreijer@kystverket.no)).

### 8.3 Task 1.1.6 Produce a Guideline on Measures to Evaluate the Effectiveness of a VTS

Work on this task was started and input papers from Australia (VTS42-8.3.1 and VTS42-8.3.2) were considered.

The first draft guideline was developed as a working document.

#### Action item:

The **Committee Secretary** is requested to forward the draft guideline WG1-WP2 (Effectiveness) (VTS42-12.2.2) as a working paper to VTS43.

### 8.4 Task 1.2.1 Produce a Guideline on public and media relations in special/defined circumstances.

Work on this task was postponed to VTS43.

### 8.5 Task 1.3.1 Produce a Recommendation / Guideline on VTS Communications

The VTS Communications sub-working group had a successful meeting. Positive progress was made with the initial draft of sections including ground rules, structure, common phrases and cross cultural communication. Work will continue at VTS 43.

Committee Members were invited to consider participation at the up-coming workshop on VTS Communication, see more under agenda item 13.2.

#### Action items:

The **Committee Secretary** is requested to forward the working document on VTS Communication (VTS42-12.2.3) as working paper to VTS 43 for further review and consideration.

**Committee members** are requested to send any relevant guidance, advice or documentation they provide to VTS personnel on effective oral communication to Thomas Southall ([Tom.Southall@pla.co.uk](mailto:Tom.Southall@pla.co.uk)), it does not necessarily have to be in English.

### 8.6 Task 1.4.2 Review/Update/Provide input to IMO on Resolution A.857(20) Guidelines for VTS

A sub-group was formed at the commencement of VTS42 to identify and document the compelling needs for a review/amendment on IMO Resolution A.857(20). It was highlighted that, since it is not (yet) on the agenda at IMO, a request for the Resolution to be updated needs a submission for an unplanned output, together with clearly defined compelling needs. IALA, being a NGO, cannot submit such a submission to IMO on its own, since it needs to be made by a Contracting Government /Member State of IMO.

A draft document entitled “*Compelling Needs for a Revision of IMO Resolution A.857(20) Guidelines for Vessel Traffic Services*” was developed and finalized by the sub-group finalized and considered by the Committee paper “VTS42-12.1.3 Compelling Needs (VTS42)”. Key components identified where amendments/changes to the Resolution are required include:

- VTSO Qualifications, Training and Certification – Mandatory Training
- Recognition of IALA VTS Standards in international instruments
- Types of Service (INS, TOS and NAS)
- Operation of VTS outside territorial seas
- Role of Competent Authority / VTS Authority
- VTS and Future Developments
- Administrative amendments

Members agreed, in principle that the components identified in the compelling needs document should provide the basis for development of a proposed submission for the Resolution to be updated as an unplanned output at VTS43. IALA Members, being also Contracting Governments to IMO, should be invited to submit the proposal of an unplanned output, preferably co-sponsored by IALA.

*Action item:*

*The **Committee Secretary** is requested to forward the paper on “Compelling Needs ” (VTS42-12.1.3) to VTS43 as an input paper for WG1 to use in the preparation of the proposed submission for a review of the resolution as an unplanned output.*

## **Miscellaneous**

### **8.7 IALA Dictionary update**

WG1, together with WG2, considered input papers VTS42-3.1.1 and VTS42-3.1.2 on proposed amendments from Guideline 1111. Minor changes were proposed to the IALA Dictionary.

Several WG1 members raised, again, concern on the IALA policy on removing definitions from IALA documents. By not having access to the explanations within the document, it may be confusing for the reader and the document will not be able to stand on its own. It is also considered unpractical since it may not be possible to have a printed version of an IALA document because you would then, beside the document itself, also need to have printed versions of the dictionary in order to understand the text completely. Furthermore, it may not be possible to be connected to the Internet at all times whenever the document will be read, which would affect the accessibility of all IALA document.

*Action item:*

*The **Committee Secretary** is requested to forward the proposed update of the IALA Dictionary (VTS42-12.1.4) and the proposed abbreviations (VTS42-12.1.5) to the IALA Dictionary Working Group for their consideration.*

### **8.8 ACCSEAS Future Work items identified in the ACCSEAS Legacy Report**

WG1, together with WG2, noted and considered input paper VTS42-3.3.3 on Future Work items identified in the ACCSEAS Legacy Report.

It is the opinion of the WG1/WG2 that before the future work items can be included in the next work program further information must be sought.

It is proposed that this will be a topic of discussion for the joint VTS/ENAV meeting on 5 August 2016.

*Action item:*

*The **Committee Secretariat** is requested to forward the liaison note (VTS42-12.1.6 WG1-liaison note accseas) to the Joint WG VTS/ENAV Working Group for discussion.*

### **8.9 VDES**

WG1 noted the input paper VTS42-8.7.1 Liaison note Draft Guidelines on User Requirements for VDES and will consider it in conjunction with Task 1.1.4 Produce a Guideline on Maritime Service Portfolios for VTS.

WG1, together with WG2, noted input paper VTS42-8.7.2 PNT relevant topics for the use of AIS/VDES.

### **8.10 Draft Guideline on Navigational Safety within Marine Spatial Planning**

WG1, together with WG2, considered liaison note from ARM (VTS42-3.5.1 and VTS42-8.5.2)

Comments and proposals on the draft guideline were submitted to ARM for their final consideration.

*Action item:*

The **Committee Secretary** is requested to forward the liaison note on Marine Spatial Planning (VTS42-12.1.7) to the ARM Committee to consider.

## 9. WORKING GROUP 2 – TD#2 - TECHNOLOGY (WG2)

### Introduction

20 people joined the Working Group, a small number for the first time including 2 delegates from the Egyptian Authority for Maritime Safety. The WG would like to express our thanks and appreciation to the Malaysian Administration for the excellent facilities, organisation and hospitality over the course of VTS42.

Tasks were presented as follows:

The WG2 had 16 papers to review, update, note and comment upon.

- VTS42-3.3.3 Future Work items identified in the ACCSEAS Legacy Report. Note
- VTS42-3.4.1 eNAV ROADMAP – Liaison Note
- VTS42-3.4.2 eNAV ROADMAP – Review and Comment
- VTS42-3.5.1 Marine Spatial Planning – Liaison Note
- VTS42-3.5.2 Marine Spatial Planning – Review and Comment back through WG1
- VTS42-9.1.1 Produce a Rec. on Portrayal of VTS Information and Data. Continue
- VTS42-9.2.1 Produce a Guideline on Acceptance of VTS Systems - Continue
- VTS42-9.3.1 Produce a Guideline on the technical interface between VTS systems and Systems of other stakeholder
- Comment on VTS Questionnaire to Neil Trainor

After presenting these tasks we discussed our approach to the management of these tasks and agreed a plan for the week. Essentially, three sub-groups were created along similar lines to VTS41.

### 9.1 Task 2.1.1 Produce a Recommendation on Portrayal of VTS Information and Data

Excellent progress was made during the course of the week. The task is scheduled for completion at VTS44. The output is a working document which should be referred to VTS43 as an input paper.

Considering the new IALA documentation structure, it is likely that an associated Guideline will need to be produced.

*Action Item:*

The **Committee Secretary** is requested to forward the working document VTS42-12.2.4 on portrayal to VTS43.

### 9.2 Task 2.2.1 Produce a Guideline on Acceptance of VTS Systems

The Group built upon the output paper from VTS41 and agreed that the Guideline should be consistent with but remain separate from Guideline 1111. Good progress was made on this task. The output is a working document which should be referred to VTS43 as an input paper. The task is scheduled for completion at VTS44, however this is likely to go into the next working period.



*Action Item:*

The **Committee Secretary** is requested to forward the working document VTS42-12.2.5 on acceptance VTS systems to VTS43.

**9.3 Task 2.3.1 Produce a Guideline on the technical interface between VTS systems and the systems of other stakeholders**

The Group continued discussions on the output document of VTS41 on how this Guideline should align with existing IALA Documents namely Guideline 1086 Global Sharing of Maritime Data and Guideline 1102 VTS Interaction with Allied Services.

The Group produced a structure which is aligned with both Guidelines 1086 and 1102. The substance of the document progressed well and the output is a working document which should be referred to VTS43 as an input paper. The task is scheduled for completion at VTS44

*Action Item:*

The **Committee Secretary** is requested to forward the working document VTS42-12.2.6 on technical interface with other stakeholders to VTS43.

**9.4 VTS42.3.1.1 Review and Comment on the International Dictionary of Marine Aids to Navigation**

Amendment Proposal - Reference: VTS3.1.1 (VTS41-12.2.16)

The Group reviewed the clarifications on definitions requested by the Dictionary Working Group in light of the publication of Guideline 1111 in the context of an original document submitted to VTS41 and subsequent outcomes from the 5<sup>th</sup> Meeting of the Dictionary Working Group (DWG5) on 1<sup>st</sup> July 2016. Definitions were agreed and the outcome will be forwarded to the DWG as output paper VTS42-12.1.4 (see action in chapter 8.7 WG1).

Members of WG2 expressed significant concern over the policy to remove definitions from IALA documents as this will impact the readability and understanding of the technical documents.

**9.5 VTS42.3.1.2 Review and Comment on the International Dictionary of Marine Aids to Navigation**

Amendment Proposal - Reference: VTS42-3.1.2 (VTS41-12.2.17)

The Group reviewed the paper in liaison with WG1 and subsequently during Plenary. The WGs agreed that commonly used abbreviations which were used outside of IALA could be removed from the Dictionary. We agreed that the reference for those abbreviations unique to VTS should have the source stated as IALA with examples of Guidelines where the abbreviations are defined such as 1089 and 1110. WG1 will provide an overall response in the form of output paper VTS42-12.1.5 (see action in chapter 8.7 WG1).

**9.6 VTS42.3.4.2 Review and comment on IALA e-navigation ROADMAP for 2016 and beyond**

The Group reviewed the IALA e-navigation Roadmap for 2016 and beyond and welcomed the paper. The group collated comments from all working groups which resulted in output paper VTS42-12.1.8.

*Action Item:*

The **Committee Secretary** is requested to forward the liaison note on the IALA e-navigation Road Map (VTS42-12.1.8) to the ENAV Committee and the Joint WG VTS-ENAV.

**9.7 VTS42.3.5.2 Review and comment on draft Guideline on Navigational Safety within Marine Spatial Planning**

The Group reviewed the paper and made a number of comments and suggestions which were passed on to WG1 for incorporation into an output paper.

### 9.8 VTS42.6.2.1 Draft Report on VTS Questionnaire results

The Group was asked to pass any comments on this Draft report to Neil Trainor via the WG Chairs.

The remarks are that the results of the “categorisation codes” are missing in the preliminary report, these are asked to be published.

## 10. WORKING GROUP 3 – TD#3 – VTS TRAINING (WG3)

### Qualification, training, and certification of VTS personnel

#### 10.1 Task 3.1.3 – Review and update IALA Recommendation V-103 on the Standards for Training and Certification of VTS Personnel and other guidance

Work on the review of IALA Recommendation V-103 continued with respect to incorporating Model Course V-103/5 into the document. Additional minor modifications (including revisions to the definitions) to the Recommendation have also been proposed to give effect to changes made in other IALA documentation related to VTS training (specifically, Guideline 1014 and 1103).

Members of the VTS Committee are requested to review the draft revisions to Recommendation V-103 and to send any comments to the Chair and Vice Chair of Working Group 3 by Thursday 1<sup>st</sup> December 2016. The revisions to Recommendation V-103 will be offered for approval at VTS43.

#### Action items:

*The **Committee Secretary** is requested to forward working document on the revision of V-103 (VTS42-12.2.7) as input for VTS43.*

***Members of the VTS Committee** are requested to provide comments on the draft revisions of IALA Recommendation V-103 to the Chair and Vice Chair of Working Group 3 by Thursday 1<sup>st</sup> December 2016.*

#### 10.2 Task 3.1.2 Produce a VTS Training Manual to complement the V-103 and its model courses

The Working Group did not progress the work programme item related to the VTS Training Manual due to the workload related to other matters.

#### 10.3 Input paper VTS Manager training need (VTS42-10.2.2)

The Working Group considered the input paper concerning VTS Manager training. The paper was very well received in the Working Group and it was felt that it was an essential item for inclusion on the 2018-2022 work programme of the VTS Committee.

The Working Group examined the potential scope of a new work programme item and concluded that the item should be directed at the management of a VTS as opposed to the specific VTS Manager role. This reflects that not all VTS Authorities have dedicated VTS Manager positions but all VTS Authorities are required to have effective VTS Management activities and processes in place.

A preliminary review of the roles, competencies and tasks related to the effective management of a VTS took place centred around the following key themes related to quality and safety management systems:

- Operational management of a VTS,
- Technological, financial and human resource management of a VTS,
- Interpersonal/inter-organisational communication (internal and external).

The provision of a short questionnaire aimed at identifying and examining the various VTS Management competencies was discussed – whilst it was determined that a questionnaire could be helpful it was decided to initially review the potential competencies within the Working Group to ascertain if consensus could be reached.

The Working Group also considered the type of document that should be produced with respect to VTS Management. A Model Course and Guideline were considered – it was generally felt that a Guideline could provide a more flexible tool with more direct applicability across the entire VTS sector.

Working Group 3 considered that in the preparation of this guidance assistance and feedback would be required from Working Groups 1 and 2.

*Action item:*

*The **Committee Secretary** is requested to forward working document on VTS Manager training VTS42-12.2.8 (VTS42-10.2.2) as input for VTS43.*

#### 10.4 Task 1.4.2 – Review/Update/Provide Input to IMO On Resolution A.857(20) Guidelines For VTS

Working Group 3 considered the request to provide input on the establishment of a compelling need to review IMO Resolution A.857(20). Specifically, the Working Group reviewed the Resolution as it applies to VTS personnel and training issues.

##### Overarching compelling need

The Resolution was written before the formulation of IALA Recommendation V-103 and its associated Model Courses and Guidelines.

Consequently, the structure and terminology used within the Resolution is now either in conflict with or constraining the necessary continued development of modern IALA training Recommendations, Model Courses and Guidelines.

Therefore, consideration should be given to removing Annex 2 (and associated other sections) of the Resolution and replacing it with a shorter section that gives long-term effect to a new IALA Standard and associated Recommendations, Model Courses and Guidelines thereby setting out an international basis and framework for the training and certification of VTS personnel.

##### Examples supporting compelling need

- A number of the definitions and associated sections contained within the Resolution are not compatible with the content and structure of IALA training related documentation.
- The elements of the Resolution related to training are relatively lengthy and are now incorporated in IALA Recommendation V-103 and further expanded upon in its associated Guidelines and Model Courses.

#### 10.5 Review of output from IALA VTS Questionnaire

The Working Group considered the draft output from the first IALA VTS Questionnaire, the Working Group made several observations related to the results. In particular, the Working Group noted the responses to the questions related to the provision of the various IALA Model Courses. The results for the questions related to the provision of V-103/2, V-103/3 and V-103/4 Model Courses prompted some debate as, on paper, the take up of these courses seemed relatively low although this could potentially be explainable.

The Working Group also discussed the mixed responses with respect to the provision of Accredited VTS Training Organisations.

Additionally, the results of the VTS Questionnaire served to validate the requirement for the development of guidance on Human Factors and Ergonomics in VTS in addition to further supporting the requirement for the provision of guidance on the management of a VTS.

*Action item:*

*The **Committee Secretary** is requested to forward the feedback of Working Group 3 to the editor of the VTS Questionnaire.*

## 10.6 Continued applicability of IALA Guideline 1017 on the assessment of training requirements for existing VTS personnel, candidate VTS operators, revalidation of VTS operator certificates

The Working Group considered the continued applicability of IALA Guideline 1017 in the light of recent training developments including the implementation of IALA Model Course V-103/5. The Working Group considered that there was still useful information contained within the Guideline, especially for authorities developing VTS.

The Working Group considered that the Guideline did repeat some matters which are now dealt with in other IALA documentation but that the matters were not in conflict with one another. It was considered that when IALA documentation related to training is reviewed, specifically the IALA VTS Model Courses the key elements of Guideline 1017 may be usefully incorporated into them.

### Accreditation and approval process for VTS training

## 10.7 Input paper VTS40\_10\_1\_3 (now on hold paper 1.4 VTS Certification)

The Working Group briefly revisited this paper and requested members of Working Group 3 to provide examples of VTS Certification (including VTS Certification Logs or equivalent documents) for review to enable an assessment to be made as to whether further guidance is required on this matter.

#### Action item:

**Members of the Working Group 3** are requested to provide examples of VTS Certification (including VTS Certification Logs or equivalent documents) to Burçin Erlevent by VTS43.

### Human Factors and Ergonomics

## 10.8 Task 3.3.1 Develop guidance on Human Factors and Ergonomics in VTS

The Working Group reviewed and noted input paper VTS42\_3\_3\_1 consisting of a Liaison Note from the e-Navigation Committee and accompanying paper summarising the Faros project related to Human Factor Management. The Working Group commenced the preparation of guidance on Human Factors and Ergonomics in VTS by means of commencing a literature review of the input papers submitted to date, the output of the IALA Workshop on Human Factors and Ergonomics in VTS and other resources and expertise provided by members of the Working Group.

A draft framework for the preparation and prioritisation of guidance on Human Factors and Ergonomics in VTS was drafted and work commenced. Additionally, a specific folder within the WG3 area of the IALA file sharing site related to Human Factors and Ergonomics was created to act as a repository for the literature currently under review. The Working Group also considered that it may be beneficial to set up a free web-based forum or equivalent to enable effective communication on this work item out of committee.

#### Action item:

The **Committee Secretary** is requested to forward working document on Human Factors (VTS42-12.2.9) as working paper for VTS43.

### VTS training for navigating officers

## 10.9 Task 3.4.1 Develop a Guideline on VTS Awareness for Navigating Officers

This task was not commenced at VTS40 and is provisionally programmed for consideration at VTS43 and VTS44.

#### Action item:

**Members of the VTS Committee** are requested to provide examples of training / familiarisation programmes / seminars / documents related to VTS Awareness for Navigating Officers to the Chair and Vice Chair of Working Group 3 for review and consideration.
