Report by the IALA Secretary General ¹

Executive Summary

This document makes recommendations on the future venue and format of the 2016 IALA VTS Symposium.

General

Councillors will recall the recent Council 54 discussions under Agenda Item 13, IALA Conference & Symposia and in particular the conversation surrounding the venue and format of the 2016 Symposium (see C54/13-3/1). Council concluded that discussion and requested the following be completed as inter-sessional actions:

- 16 The Secretary-General and the Council member for the USA are requested to investigate a possible partnership deal, with a reputable partner, and report to the Council inter-sessionally.*
- 17 The Secretary-General is requested to investigate alternative hosting venues and report to the Council.*

New IALA Symposium Method Proposal - Seattle, 2016

The United States Coast Guard (USCG) Councillor has provided additional information for the consideration of Council, including an alternate proposal for the hosting arrangements for the 2016 Symposium, and suggested changes to its format. This information is summarised in Attachment A: *Strength, Weaknesses, Opportunities, Threats (SWOT) Analysis*. The analysis contained in the SWOT, summarises all the issues associated with any change to the current practice of conducting Symposia.

Alternate hosting venue – Malaysia, 2016

Councillors will also recall that during Council 54, the Malaysian Councillor also offered the option of hosting the 2016 Symposium in Malaysia.

Discussion

Both options as presented offer opportunities for IALA.

The suggested broadening of the Symposium scope to capture 'future navigation' by the USCG is in line with previous discussions held in Council on how to incorporate developments in other areas of IALA's activity with the conduct of Symposia.

The new funding and hosting arrangements, as suggested by the USCG for the 2016 Symposium, present both prospects and challenges as documented in the SWOT analysis. The USCG offer would require significant modification to the current IALA Guideline (Internal) *Preparation of a Conference or Symposium, Edition 4* last endorsed by Council in December 2012.

The offer of Malaysia to host the 2016 Symposium is also considered in the SWOT analysis but does not necessitate a change in the current practice of conducting a Symposium.

Recommendation

IALA is in the very fortunate situation to have two offers available for the conduct of the 2016 Symposium. From the perspective of Secretary General, I would like to recommend that IALA Council accept the offer of Malaysia to host on this occasion, but that the scope of the Symposium is extended as suggested by the USCG to include 'future navigation'. This outcome would present the lowest risk to IALA from a financial and secretariat workload perspective and also accommodate an expansion in the subject matter as previously discussed at Council.

Action requested of the Council:

1. The Council is invited to **note** the Secretary General's report and its attachment **with a view to agreeing** on the 2016 VTS Symposium being hosted by Malaysia - with an extended scope to include 'future navigation' – at its 55th session.

New IALA Symposium Method Proposal

Seattle, 2016

Strength, Weaknesses, Opportunities, Threats (SWOT) Analysis

Proposal: IALA partner with one or more commercial entities to produce a 2016 symposium focused on future navigation (specific title and theme to be determined, but broader than VTS)². US councilor and staff to act as Secretary General's and Association's agent for dealing with the commercial partner(s) for production of the event.

The following analysis includes SWOTs that are unique to producing a symposium in this new way.

Strengths	Weaknesses
Event logistics entirely managed by experienced professionals	VTS committee preceding the event would not be included/ managed by event staff ⁴
Event designed to increase overall attendance	No Council meeting in Seattle prior to the event ⁵
The Seattle location provides attendees to visit a location where traffic is managed cooperatively between Canada & US VTSS ³	Increased workload for Secretariat
Opportunities	Threats
IALA branding & awareness in maritime community improves	Possible disagreements between IALA & symposium partner(s)
Attendance by broader maritime community w/ improved professional exchange	Possible need to increase registration fees beyond amount provided in IALA guideline
Increased IALA membership (especially industrial)	"First time" learning experiences cause extra effort
Broader scope makes event more productive & important for maritime community	
Success leads IALA to hold similar events in countries that are unable to sponsor/subsidize	

- Two entities have expressed strong interest in hosting the event.
 - The Institute of Navigation regularly hosts events with over 1,000 attendees
 - Phillips Publishing hosts an annual E-Nav symposium with approximately 300 attendees
- Strong recommendation from staff to include "VTS" as part of the name for the event to ensure we don't lose those attendees.

² Could also be true if the Council accepted Malaysia's offer to host the 2016 event

³ If the Council accepted Malaysia's offer to host the 2016 event, attendees might see similar international cooperation

⁴ The VTS committee has met in conjunction with the VTS Symposium twice. This is just to clarify that, as the event would not be a VTS symposium, the VTS committee meeting would not need to be in the same location. Also, the US is unable to commit to hosting that VTS meeting.
