Report of the 7th Steering Committee Meeting

IALA Headquarters – 23rd October 2013

Mr. Gary Prosser, the IALA Secretary General, opened the meeting at 09h00 and welcomed everyone to the meeting.

The meeting was attended by 13 participants. A full List of participants is given at **Annex 1**.

The Agenda was approved after it was made clear that it was a standard Agenda and not all items would be discussed.

Mr Prosser had to leave the meeting, due to another engagement. He handed over the chairmanship to Marie-Hélène Grillet, who was also Secretary to the meeting.

The Agenda for the meeting is attached at **Annex 2**.

Agenda items 1) to 4) and item 6) had been dealt with during previous meetings. Agenda item 5): the list of Chairs previously agreed, was confirmed. Two selected Chairs (John Festarini of Canada and Paulo Mauricio of Brazil), had indicated that they would be able to confirm their availability at a later date. It was decided to keep their names on the list but arrange for potential replacements. The final list of session Chairs and Vice-Chairs is attached at **Annex 3**.

7) Update from Spain

- 7.1 Registrations: online registrations and hotel bookings were operational. The Organizers however still needed to find a way for the IALA staff members to register online without paying the fees.
VAT cannot be waived for registration fees but exhibiting companies will be able to claim it back.
- 7.2 Exhibition: it was suggested, in case not all booths were sold, to rearrange the Exhibition shape by either extending the booth size or not using the extension.

- 7.3 Lighthouse Exhibition: an exhibition on lighthouses will be held in A Coruña concurrently with the Conference. The exhibition opening hours are still to be decided. The Organizers will arrange for the participants to be able to visit the exhibition free of charge.
- 7.4 Meeting of Spanish speaking member countries: a meeting of representatives from Spanish speaking member countries – mainly from Spain and South America – will be held some time during the Conference. The meeting is intended for Aids to Navigation technicians who will be given the opportunity to discuss technical subjects in the Spanish language. It should not be seen as a competitor to the Conference.
- 7.5 Buoy tenders: the Organizers reported that no IALA National Members have expressed their intention to send service vessel to A Coruña. It was agreed that it was not appropriate to send out an invitation but Council should be reminded of the opportunity at its next session in December 2013.

Action item 1: The Secretariat to inform the Council that buoy tenders and other service vessels are welcome at A Coruña for the Conference. Councillors interested should make contact with the Spanish Organizers.

8) Draft Conference programme

- 8.1 Day 1 and opening ceremony. A programme for Day 1 and the opening ceremony was tentatively agreed as shown in **Annex 4**.
- 8.2 Update on abstract selection. Over 125 abstracts had been received; 93 were retained for presentation. Due to their similarities some papers were accepted subject to their merger with others, achieving a total of 84 expected presentations. A reserve list was also drawn up. Abstracts on the reserve list, if not presented, will be developed as papers to be included in the Conference documentation along with those that will be presented. A list of retained abstracts is presented at **Annex 5**.
- 8.3 Structure of technical sessions. There was no change to the proposed technical sessions as they appear in the First Announcement circulated in June 2013.
- 8.4 Best practice award. Philippe Lijour of France was selected as Chair of the session, provided that he is available. Ten proposals from the 14 received will be selected for presentation by the Organizers. Giving awards at this session has yet to be decided.

The final Conference Programme should be issued in January 2014 and all presenters should be informed when and with whom they will present. The information should go to the selected authors in early December. At the same time authors who have passed the deadline for submission will be reminded to submit their papers without delay.

Action item 2: The Secretariat and Organizers to finalize the Conference Programme for publication in January.

Action item 3: The Secretariat to send information and reminders to the presenters in early December.

9) Check off the tasks to be carried out by IALA to date against the IALA (internal) Guideline for the Preparation of a Conference or Symposium

Preparation work progresses according to the time schedule.

10) IALA staff at Conference

Decision on the composition of the IALA Staff is left with the Secretary General. The Organizers already agreed the budget sent by the IALA Secretariat prior to SC6.

11) Industrial Exhibition

The IMC reported that 46 booths had been sold to date. A reminder was circulated together with the IALA Bulletin and is sent again every month to all IM who have not registered for the Exhibition.

The venue for the Industrial Evening had to be changed. The party will now take place at the Marina.

The IMC will sponsor some delegates from developing countries, according to a list that will be developed by the IALA WWA. This will target South American countries.

Action item 4: The WWA to prepare a list of potential sponsored delegates for the Secretariat to arrange their participation, similar to what was done in Cape Town.

12) Any other business

12.1 WWA Seminar. The programme has been changed and registrations are still awaited.

12.2 Diplomatic Conference. A Diplomatic Conference on IALA status change had been envisaged concurrently with the Conference. The meeting held with National Members in Copenhagen in October proved that this time line was too short and the Diplomatic Conference will therefore be held at a later stage and somewhere else, probably in France.

12.3 Visit of HRH Princess Ann. The Master of Trinity House has indicated that she is considering visiting the Conference. The Organizers suggested Tuesday 27th or Thursday 29th May. A final agreement has still to be made with Buckingham Palace.

12.3 Industrial Member's Assembly. The Assembly will require a meeting place for about 100 people for 2 hours on Thursday 29th or Friday 30th May.

Action item 5: The Organizers to arrange for a room able to accommodate 100 people to be available on either Thursday 29th or Friday 30th for the Industrial Members' Assembly.

12.4 Presenting in Spanish at Best Practice and Heritage sessions. It was agreed that presenters may speak in Spanish during these sessions. The presentations, however, should be written in English.

12.5 Maritime Cloud presentation. The presentation will be made available to all participants on the tablets. In order to test the functionalities it was agreed that the Organizers would provide Omar-Fritz Eriksson with one of them in February 2014.

Action item 6: The Organizers to provide Omar-Fritz Eriksson with a tablet in February 2014.

13) Date and place of next meeting

The next meeting will be held on 25th March 2014 at A Coruña. It is not expected that all Steering Committee members will take part. A confirmation will be sent in due time.

In the meantime a teleconference may be held on 14th January at 100 GMT if needed.
