# **MEMORANDUM OF UNDERSTANDING**

## **CO-OPERATION**

### **WHEREAS:**

The International Association of Marine Aids to Navigation and Lighthouse Authorities (“**IALA**”) is a non-profit making international technical association established in 1957 to foster safe, economic and efficient movement of vessels through improvement and harmonisation of aids to navigation worldwide and other appropriate means, for the benefit of the maritime community and the protection of the environment; and

IALA is a secular and non-political NGO made up of members including marine aids to navigation authorities, manufacturers and consultants from all parts of the world; and

IALA has five committees and each meets twice a year, usually at its headquarters and IALA conducts conferences, symposiums, workshops and seminars to facilitate the work of IALA at venues world-wide; and

IALA maintains a permanent Executive and Secretariat at its headquarters; and

[name of country] (“**Host**”) has agreed to be the host country for the headquarters of IALA; and

the Host and IALA have reached an understanding about the mutual cooperation between both parties; and

the Host and IALA wish to record that understanding in the form of this memorandum of understanding (“**MOU**”):

### **THIS MEMORANDUM OF UNDERSTANDING NOTES:**

#### **The Host**

The Host, through the [name of the relevant Office responsible for Aids to Navigation/Transport portfolio in the host country] will provide support and recognition to IALA as an international non-government organization with permanent headquarters located in the Host.

## **Support**

The support provided by the Host will include the following:

- a) assistance with the employment by IALA of non-residents of the Host, such as fast tracking visa applications where required and obtaining necessary work permits;
- b) engaging in a regular communication strategy to be established between the Secretary-General of IALA and the Director-General of the Maritime Agency/Transport portfolio [describe person who is the senior member of the Host government responsible for the management of aids to navigation and maritime safety] and to be established between the Secretariat of IALA and appropriate staff within the Host government Maritime Agency/Transport portfolio; and
- c) ??

## **Recognition**

The Host will provide recognition of IALA including the following:

- a) recognition of the status of IALA as an international NGO, with [special provisions to be negotiated which may include taxation status of the Secretary-General and other staff; assistance to employees in meeting local conditions];
- b) recognition of the status of IALA by providing the name of a key contact in the Host government at the appropriate level [equal to the senior member of the Host government responsible for the management of aids to navigation and maritime safety] for communications with the IALA Secretary-General on a regular basis and as required;
- c) the provision of additional facilities to IALA when required for large conferences, symposiums etc, as far as practical; and

## **IALA**

IALA will cooperate with the Host in conduct of IALA activities, including:

- a) IALA will acknowledge the support from the Host in its publications where appropriate;
- b) IALA will provide the Host with an annual report of the committee meetings expected to be conducted during the coming 12 months, with a general estimate of the numbers of attendees and the countries of origin of the likely international attendees;
- c) IALA will conduct at least [80%?] of its committee meetings in the Host country and will conduct at least [50%?] of its workshops, forums and symposiums within the Host country on an annual basis; and

### Special provisions [as negotiated]

The parties have also decided to

- a) seat on Council (would need a change of the constitution);
- b) subsidy from Host to IALA for cost of relocation to new building and on-going subsidy for costs of occupation
- c) provision of suitable venues to host meetings/social functions within Host
- d) Assistance with translation services into language of Host where required

### Disputes

Any differences of opinion as to the operation of this MOU will be discussed and solved by the Secretary-General of IALA and the Director-General of .... If the parties are unable to meet a mutual resolution of any differences, the opinion of [who?] will be sought and both parties will accept that opinion as determinative of the issue.

### Term

This MOU will commence on the date that both parties sign the MOU and will continue in operation until IALA and Host mutually agree that it should be terminated or, if there is no mutual agreement, on the provision of 12 months' written notice by either party to the other that the MOU will be terminated.
