##### 10.4.1 – VTS50 summary report

#### 1. INTRODUCTION

The 50th meeting of the VTS Committee was held virtually from 10 - 31 March 2021. 170 Participants from 33 countries, 5 Sister organisations participated. 41 participants attended for the first time.

The Committee revised the work programme based on the decision of the Council and worked on the extended work period 2018-2023. Working in three working groups, the Committee considered 93 input papers, including presentations and produced 42 output and working documents. Please refer to the annex for the overall status.
